

QUIKSILVER, INC.'S 8 WEEKS OF RADNESS/ WEEK 6 - GOPRO GIVEAWAY
SWEEPSTAKES PROMOTION–OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER. VOID WHERE PROHIBITED BY LAW.

1. **Who Can Enter:** Any legal resident of the U.S. or Canada, 13 years of age or older, is eligible to participate in Quiksilver, Inc's 8 weeks of radness/week 6 - GoPro Giveaway Sweepstakes (the "Sweepstakes"). Employees, officers, principals, directors or agents of Quiksilver, Inc. or its subsidiaries or affiliates (collectively, the "Sponsor"), and members of their households or immediate families, are not eligible to participate.

2. **How to Enter:** Each entrant must register and complete the online entry form at <http://www.blog.quiksilver.com> (the "Sweepstakes Website"). The online entry form must be submitted between 12:00:00 a.m. Pacific Time on December 6, 2012 ("Sweepstakes Open Time") and 11:59:59 p.m. Pacific Time on December 11, 2012 ("Sweepstakes Close Time"). Any entries that are incomplete, late or not properly submitted will be disqualified.

3. **Sweepstakes Dates:** The Sweepstakes will begin at the Sweepstakes Open Time and end exactly at the Sweepstakes Close Time. The prize drawing will be held based on number of eligible Sweepstakes entries properly submitted, completed and received between the Sweepstakes Open Time and the Sweepstakes Close Time.

Entries will be deemed to have been submitted by the authorized account holder of the e-mail address submitted at the time of entry. "Authorized Account Holder" is defined as the natural person who is assigned to an e-mail address by an Internet access provider, online service provider, or other organization (e.g. business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address.

4. **Prizes:** One (1) winner will be chosen at random. The winner will receive one (1) GoPro Surf HD Hero 2 Camera; one (1) 16GB SD Camera Card; and one (1) Grab Bag Camera Mounts. The prize has an approximate retail value of \$359.97 USD. Sponsor is not responsible if potential winners are unable or unavailable to accept the prize. Sponsor reserves the right, in its sole discretion and for whatever reason, to add and/or substitute items to the prize based on availability. 5. **Prize Drawings:** The winners will be selected in a random drawing conducted by Sponsor based on eligible entries form properly submitted between the Sweepstakes Open Time and the Sweepstakes Close Time. The winner will be chosen at random from online entries by a representative from Sponsor on December 14, 2012 at Sponsor's headquarters in Huntington Beach, California.

6. **Odds of Winning:** Each entrant's odds of winning are dependent on the aggregate number of eligible entries form properly submitted between the Sweepstakes Open Time and the Sweepstakes Close Time. No purchase of any kind is necessary in order to enter the Sweepstakes or win any prize, and chances of winning are not enhanced by making any purchases.

7. Winner Notification: The winner will be notified via e-mail within 48 hours of awarding of the prize. The winner will be required to respond to the e-mail notification to acknowledge receipt of the Sponsor's notification and awarding of the prize.
